Triad Home Gets 公公公公士 Energy Rating EPA Energy Star Home - Highest Rating on the East Coast

Ken and Dolly Eller of 335 Tippy Lane, Clemmons, NC, wanted an energy efficient home for retirement. What they built was a house that received, a 5 Star Plus, 92.6 energy efficiency rating. Michael Guy, ADONAl Building Science, did the rating, said this is the highest rating he has seen on the east coast. The Home Energy Rating Service (HERS) is a means of evaluating a residence for energy efficiency. In order to meet the Energy star Program requirements the HERS score must exceed the NC Building Code by at least 30%. The Eller's score exceeds the NC code by more than 50%. A rater must be approved and service is supported by the Environmental Protection Agency and the Department of Energy. This process is required for certification of homes meeting the EPA/DOE Energy Star Program.

The house uses the newest energy efficient building methods to manage the 2756 square foot 3 bedroom living space. Insulated Component Structures of Mocksville, NC provided structural insulated wall panels that have an insulation value of R-30. The Ellers installed a direct ground source heat pump for water heating and warming or cooling the house. The structural-thermal envelope is so efficient that outside air must be supplied. Their ventilation system, that provides a supply of fresh air, is 70% efficient and the appliances are energy star rated. The test consists of using the blower test method. ADONAI estimated that the annual energy cost would be \$1266. An additional benefit of an Energy Star house is that lending institutions provide loans with a higher loan to value.

Raynor Investments of Lexington was the builder. He has built another house in the Lexington area and an energy efficient classroom at Davie County High School. All three of these projects used structural insulated panels.
